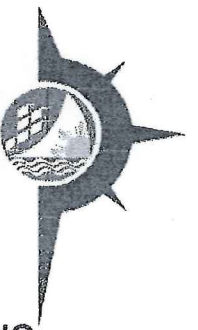

**BAC RESOLUTION DECLARING FAILURE OF BIDDING AND RECOMMENDING APPROVAL**

**REPOSTING: ONE (1) LOT SUPPLY OF MATERIALS, AND EQUIPMENT FOR THE PROCUREMENT OF VARIOUS CARPENTRY TOOLS FOR THE PREVENTIVE MAINTENANCE OF PORT FACILITIES, PORT OF ZAMBOANGA, ZAMBOANGA CITY WITH AN ABC OF PHP225,950.76**

WHEREAS, the Philippine Ports Authority, PMO Zamboanga, through its Bids and Awards Committee (BAC) and in accordance with the Revised IRR of RA 9184 posted and advertised the Invitation to Bid including the Bidding Documents for the **REPOSTING: ONE (1) LOT SUPPLY OF MATERIALS, AND EQUIPMENT FOR THE PROCUREMENT OF VARIOUS CARPENTRY TOOLS FOR THE PREVENTIVE MAINTENANCE OF PORT FACILITIES, PORT OF ZAMBOANGA, ZAMBOANGA CITY WITH AN ABC OF PHP225,950.76** on January 8 to 15, 2024, in the PPA Procurement Webpage, Philippine Government Electronic Procurement System (PhilGEPS), PMO Bulletin Boards;

WHEREAS, the procurement is conducted through Negotiated Procurement-Small Value Procurement (Sec. 53.9) and the amount does not exceed the threshold prescribed in Annex H of the IRR;

WHEREAS, the BAC sent Request for Quotation (RFQ) to three (3) suppliers, namely: Asiatic Trading Corp.; Victorious General Merchandise and Services, and Nationwide Sales Corp.;

WHEREAS, the BAC opened the sealed price quotation of supplier on January 16, 2024, at 10:00AM. Only Nationwide Sales Corp submitted their price quotation envelope before the deadline;

WHEREAS, the submitted price quotation is incomplete;

NOW THEREFORE, We, the Members of the PMO Zamboanga Bids and Awards Committee, hereby RESOLVE as it is hereby RESOLVED:

To declare the procurement of **REPOSTING: ONE (1) LOT SUPPLY OF MATERIALS, AND EQUIPMENT FOR THE PROCUREMENT OF VARIOUS CARPENTRY TOOLS FOR THE PREVENTIVE MAINTENANCE OF PORT FACILITIES, PORT OF ZAMBOANGA, ZAMBOANGA CITY WITH AN ABC OF PHP225,950.76** as Failure of Bidding since submitted price quotation is incomplete and that the target date for the posting of the Request for Quotation (RFQs) is on January 19, 2024 to January 25, 2024 and the opening of price quotation envelope is on January 26, 2024.


