WHEREAS, the Philippine Ports Authority (PPA), Port Management Office (PMO) -Zamboanga, through its Bids and Awards (BAC) and in accordance with the Revised IRR of RA 9184 posted and advertised the Request for Quotation (RFQ) of the project: **SUPPLY OF MATERIALS, LABOR AND EQUIPMENT FOR SUPPLY OF LABOR, MATERIALS AND EQUIPMENT FOR "EMERGENCY PROVISION OF 4 UNITS ELECTRONIC GATE BARRIER AT THE ENTRANCE/EXIT - OPERATIONAL GATES" AT PORT OF ZAMBOANGA, ZAMBOANGA CITY (RM-02-2020)** in the amount of **Nine Hundred Fifty Six Thousand Four Hundred Thirty Two Pesos and 71/100 (Php956,432.71)** as the **Approved Budget for the Contract (ABC)** on November 27, 2020 to December 3, 2020 in the PPA and Philippine Government Electronic Procurement System (PhilGEPS) websites, and PMO-Zamboanga's Bulletin Board;
