



ONE (1) LOT - SUPPLY AND DELIVERY OF FOURTEEN (14) UNITS AIRCONDITION (FLOOR MOUNTED, SPLIT AND WINDOW TYPE) WITH INVERTER AND REMOTE CONTROL FOR PPA, PMO-ZAMBOANGA CITY

BAC RESOLUTION DECLARING SINGLE CALCULATED AND RESPONSIVE BID AND RECOMMENDING APPROVAL

BAC RESOLUTION NO. PB- 35 -2018

WHEREAS, the Philippine Ports Authority, PMO-Zamboanga, through its Bids and Awards Committee (BAC) and in accordance with the Revised IRR of RA 9184 posted and advertised the Invitation to Bid and Bidding Documents for the One (1) Lot – Supply and Delivery of Fourteen (14) Units Aircondition (Floor Mounted, Split and Window Type) with Inverter and Remote Control for PPA, PPA, PMO-Zamboanga City with an Approved Budget for the Contract (ABC) of Php 1,210,500.00 on November 26, 2018 up to the opening of bids on December 17, 2018, in the PPA Website, PhilGEPS Website, and in the PMO Bulletin Boards;

WHEREAS, in response to the said advertisements, there was one (1) supplier, Victorious General Merchandise and Services, who signified its intention to apply for the public bidding of the above-mentioned procurement and purchased the bid documents during the prescribed schedule;

WHEREAS, the BAC conducted a **Pre-Bid Conference** on **December 4, 2018** discussing among others the eligibility, technical, and financial requirements of the project to be bid pursuant to Section 22 of the RA 9184;

WHEREAS, in the **receipt and opening of bids**, the prospective bidder, Victorious General Merchandise and Services submitted the bid envelopes before the deadline, which was opened on **December 17, 2018 at 2:00 PM**;

WHEREAS, the BAC opened first the **Technical Envelope** of the lone bidder and checked each item of the technical documents against a checklist using a non-discretionary “pass/fail” criterion. The BAC found the technical documents compliant per requirements in **ITB Clause 12. Documents Comprising the Bid: Eligibility and Technical Components** and rated as “PASSED”;

WHEREAS, the BAC proceeded to open the Second Envelope of the lone bidder and checked its financial documents against the requirements prescribed in **ITB Clause 13. Documents Comprising the Bid: Financial Component**. The Chairperson announced that the submitted financial documents found compliant and the bid amount **as read: Php 1,185,278.00** less than the ABC of **Php 1,210,500.00**. The BAC rated the financial bid as “PASSED”;

WHEREAS, the BAC conducted the detailed evaluation of Bid on December 18, 2018, after the lone bidder passed the opening and checking of its technical and financial Bids pursuant to **ITB Clause 24. Opening and Preliminary Examination of Bids**, to determine the Single Calculated Bid;

WHEREAS, in the bid evaluation, the BAC determined the calculated bid price of **Victorious General Merchandise and Services at Php 1,185,278.00**;

WHEREAS, after the bid had been received, opened, examined, and evaluated, the BAC passed a motion to declare the **BID OF VICTORIOUS GENERAL MERCHANDISE AND SERVICES AS THE SINGLE CALCULATED BID**;

WHEREAS, upon post-qualification conducted on December 20, 2018 on the submitted eligibility, technical, and financial documents of Victorious General Merchandise and Services, the result of Post Qualification was **RESPONSIVE**;

NOW, THEREFORE, We, the Members of the PMO-Zamboanga Bids and Awards Committee, hereby **RESOLVE** as it is hereby **RESOLVED**:




- b) To recommend for approval by the Port Manager of the PPA, PMO-Zamboanga, Zamboanga City the foregoing findings.


