***BAC Resolution Declaring Single Calculated and Responsive Bid (SCRB)
and Recommending Approval***

BAC RESOLUTION NO. ZAM-PGCEPCS-06-2019

WHEREAS, the Philippine Ports Authority, PMO-Zamboanga, through its Bids and Awards Committee (BAC) and in accordance with the Revised IRR of RA 9184 posted and advertised the Invitation to Bid (Second Bidding) and Bidding Documents for the project re: **Repair of Powerhouse Building Including CFS Building Electrical System and Walk Shed Lighting, Port of Zamboanga, Zamboanga City** in the amount of **Fifteen Million Two Hundred Eighty Three Thousand Four Hundred Sixteen & 82/100 Pesos (Php15,283,416.82)** as the Approved Budget for the Contract (ABC) on December 4, 2019 up to the submission of bids on December 20, 2019 in the PPA Website, the Philippine Government Electronic Procurement System (PhilGEPS), and the PMO-Zamboanga Bulletin Board;

WHEREAS, in response to the said advertisements, there were two (2) Prospective Bidders who signified their intention to participate in the public bidding of the above-mentioned project and purchased the bidding documents, namely: 1. **ALRAF Construction and Enterprises**, and 2. **Three J Builders and Developer**;

WHEREAS, the BAC conducted a Pre-Bid Conference on December 12, 2019 discussing among others the eligibility, technical and financial requirements of the project to be bid pursuant to Section 22 of the RA 9184;

WHEREAS, in the submission and receipt of Bids on December 26, 2019, Bid Envelope was received from **ALRAF Construction and Enterprises** on December 26, 2019 at 8:44 A.M. and a small envelope was received from **Three J Builders and Developer** on December 23, 2019 at 9:41 A.M.;

WHEREAS, in the opening of bids, the small envelope of **Three J Builders and Developer** was opened first and stated as follows:

Three J Builders and Developer	Letter of non-participation due to their bid amount has exceeded the ABC.

WHEREAS, the BAC acknowledged the non-participation of **Three J Builders and Developer** in the bidding, and proceeded to open the bid envelope of **ALRAF Construction and Enterprises**;

WHEREAS, the Technical Envelope of **ALRAF Construction and Enterprises** was opened first and the BAC checked each item of the technical documents against a checklist using a non-discretionary "pass/fail" criterion. The BAC found the technical documents as sufficient pursuant to **ITB Clause 12. Documents Comprising the Bid: Eligibility and Technical Components** and rated as "PASSED";

WHEREAS, the BAC proceeded to open the Second Envelope of **ALRAF Construction and Enterprises** and checked its financial documents pursuant to **ITB Clause 13. Documents Comprising the Bid: Financial Component** and found the financial bid as sufficient and rated as "PASSED". The Chairperson announced the **Bid as read of ALRAF Construction and Enterprises** in the amount of **Php15,207,930.93** less than the ABC of **Php15,283,416.82**;

WHEREAS, the BAC conducted the Bid Evaluation on **December 27, 2019**, after **ALRAF Construction and Enterprises** passed the technical and financial bids pursuant to **ITB Clause 24. Opening and Preliminary Examination of Bids**, to determine the Single Calculated Bid;

WHEREAS, in the bid evaluation, the BAC conducted the detailed evaluation of the financial component of the bid of **ALRAF Construction and Enterprises** and established the correct calculated price in the amount of **Php15,207,940.73**;

WHEREAS, the BAC prepared the Abstract of Bids showing **ALRAF Construction and Enterprises** as the Single Calculated Bid;

WHEREAS, after the bid has been received, opened, examined, and evaluated, the BAC declared the **BID OF ALRAF Construction and Enterprises AS THE SINGLE CALCULATED BID in the amount of Php15,207,940.73**;

WHEREAS, upon post-qualification conducted on January 3, 2020 on the submitted eligibility, technical and financial documents of **ALRAF Construction and Enterprises**, the result of Post-Qualification was **RESPONSIVE**;

NOW THEREFORE, We, the Members of the PMO-Zamboanga Bids and Awards Committee, hereby RESOLVE as it is hereby RESOLVED:



- b) To recommend for approval by the Acting Port Manager of the PPA, PMO-Zamboanga, Zamboanga City the foregoing findings.


