

**BAC RESOLUTION DECLARING LOWEST AND RESPONSIVE QUOTATION AND
RECOMMENDING APPROVAL**

BAC RESOLUTION NO. SUP-09-2026

ONE (1) LOT SUPPLY OF LABOR, MATERIALS, TOOLS FOR THE MAINTENANCE OF ADMIN BUILDING, STAFF HOUSE AND PASSENGER TERMINAL BUILDING – ELECTRICAL WORKS (SERVICE ENTRANCE & GROUND WIRE) ADMIN BUILDING, STAFF HOUSE AND PASSENGER TERMINAL BUILDING (PTB), PORT OF IPIL, ZAMBOANGA SIBUGAY. (ZBA-405-2025) ABC=₱58,506.86

WHEREAS, the Philippine Ports Authority (PPA), Port Management Office (PMO)-Zamboanga, through its Bids and Awards Committee (BAC) and in accordance with the Revised Implementing Rules and Regulation (IRR) of Republic Act (RA) 9184 posted and advertised the Request for Quotation (RFQ) for the project: **ONE (1) LOT SUPPLY OF LABOR, MATERIALS, TOOLS FOR THE MAINTENANCE OF ADMIN BUILDING, STAFF HOUSE AND PASSENGER TERMINAL BUILDING – ELECTRICAL WORKS (SERVICE ENTRANCE & GROUND WIRE) ADMIN BUILDING, STAFF HOUSE AND PASSENGER TERMINAL BUILDING (PTB), PORT OF IPIL, ZAMBOANGA SIBUGAY. (ZBA-405-2025)** with an Approved Budget for the Contract (ABC) in the amount of Fifty Eight thousand Five Hundred Six Pesos and /86 only (**₱58,506.86**) on December 26, 2025 to January 5, 2026 in the PPA Procurement Webpage, Philippine Government Electronic Procurement System (PhilGEPS), PPA PMO-Zamboanga's Bulletin Board;

WHEREAS, the method of procurement is through Negotiated Procurement-Small Value Procurement (Sec. 53.9) and the amount does not exceed the amount threshold prescribed in Annex H of the Revised IRR of RA 9184;

WHEREAS, the BAC sent RFQs to the three (3) suppliers, namely: **MH Construction and Enterprises** on December 26, 2025, **Majda Construction and Development** on December 26, 2025 and **3A's Construction Supply** on December 26, 2025;

WHEREAS, in response to the advertisement the BAC Secretariat received a sealed envelope from **MH Construction and Enterprises** before the published deadline of submission on January 5, 2026 at 9:30 AM.

WHEREAS, during the conduct of opening of price quotation on January 5, 2026, the BAC opened, announced the quoted amount and checked each item of the eligibility documents against a checklist using a non-discretionary "pass/fail" criterion pursuant to Annex H, Section F of the Revised IRR of RA 9184. The result was:

To declare **MH Construction and Enterprises** upon the recommendation of the TWG as **Single Calculated and Responsive Quotation** in the amount of **₱57,973.13** for the procurement of **ONE (1) LOT SUPPLY OF LABOR, MATERIALS, TOOLS FOR THE MAINTENANCE OF ADMIN BUILDING, STAFF HOUSE AND PASSENGER TERMINAL BUILDING – ELECTRICAL WORKS (SERVICE ENTRANCE & GROUND WIRE) ADMIN BUILDING, STAFF HOUSE AND PASSENGER TERMINAL BUILDING (PTB), PORT OF IPIL, ZAMBOANGA SIBUGAY. 
To recommend for approval of the Port Manager of PPA, PMO-Zamboanga, Zamboanga City the foregoing findings.
