



BAC RESOLUTION DECLARING LOWEST CALCULATED AND RESPONSIVE QUOTATION AND RECOMMENDING APPROVAL

ONE (1) LOT PROVISION OF FREIGHT SHIPPING SERVICES FOR PPA PMO ZAMBOANGA FROM MARCH 21 TO DECEMBER 31, 2022, WITH AN ABC OF PHP100,000.00

WHEREAS, the Philippine Ports Authority, PMO Zamboanga, through its Bids and Awards Committee (BAC) and in accordance with the Revised IRR of RA 9184 posted and advertised the Invitation to Bid including the Bidding Documents for the One (1) Lot Provision of Freight Shipping Services for PPA PMO Zamboanga from March 16 to December 31, 2022, with an ABC of Php100,000.00, on March 4 to March 11, 2022 in the PPA Procurement Webpage, Philippine Government Electronic Procurement System (PhilGEPS), PMO Bulletin Boards.

WHEREAS, the BAC sent Request for Quotations (RFQs) to three (3) suppliers, namely 1.) JRS Business Corporation; 2.) LIBCAP Super Express Corporation, and 3.) J&T Express. Out of the three (3) only two (2) submitted their price quotation, namely LIBCAP and Super Express Corporation and JRS Business Corporation.

WHEREAS, the BAC opened the sealed price quotation of the said suppliers on March 11, 2022, at 2:00PM. The results were detailed below:






To recommend for approval by the Port Manager of the PPA, PMO-Zamboanga, Zamboanga City the foregoing findings.


