

**BAC RESOLUTION DECLARING LOWEST AND RESPONSIVE QUOTATION AND
RECOMMENDING APPROVAL**

ONE (1) LOT SUPPLY OF LABOR, MATERIALS AND TOOLS/EQUIPMENT FOR THE MAINTENANCE OF ESD FIELD OFFICE, ESD FIELD OFFICE-DOOR & WINDOW, POWERHOUSE COMPOUND, PORT OF ZAMBOANGA, ZAMBOANGA CITY (ZAM-330D-2025) WITH AN ABC OF ₱197,776.92

WHEREAS, the Philippine Ports Authority (PPA), Port Management Office (PMO)-Zamboanga, through its Bids and Awards Committee (BAC) and in accordance with the Revised Implementing Rules and Regulation (IRR) of Republic Act (RA) 9184 posted and advertised the Request for Quotation (RFQ) for the project: **ONE (1) LOT SUPPLY OF LABOR, MATERIALS AND TOOLS/EQUIPMENT FOR THE MAINTENANCE OF ESD FIELD OFFICE, ESD FIELD OFFICE-DOOR & WINDOW, POWERHOUSE COMPOUND, PORT OF ZAMBOANGA, ZAMBOANGA CITY (ZAM-330D-2025)** with an Approved Budget for the Contract (ABC) in the amount of One Hundred Ninety Seven Thousand Seven Hundred Seventy Six Pesos and /92 only (**₱197,776.92**) on October 27, 2025 to November 4, 2025 in the PPA Procurement Webpage, Philippine Government Electronic Procurement System (PhilGEPS), PPA PMO-Zamboanga's Bulletin Board;

WHEREAS, the method of procurement is through Negotiated Procurement-Small Value Procurement (Sec. 53.9) and the amount does not exceed the amount threshold prescribed in Annex H of the Revised IRR of RA 9184;

WHEREAS, the BAC sent RFQs to the three (3) suppliers, namely: **Majda Construction and Development** on November 3, 2025, **Maryam Aisha Construction** on November 3, 2025 and **Shieham Construction and Development** on November 3, 2025;

WHEREAS, in response to the advertisement the BAC Secretariat received a sealed envelope from **Maryam Aisha Construction** before the published deadline of submission on November 4, 2025 at 9:05 AM.

WHEREAS, during the conduct of opening of price quotation on November 4, 2025, the BAC opened, announced the quoted amount and checked each item of the eligibility documents against a checklist using a non-discretionary "pass/fail" criterion pursuant to Annex H, Section F of the Revised IRR of RA 9184. The result was:

To declare **Maryam Aisha Construction** upon the recommendation of the TWG as **Lowest Calculated and Responsive Quotation** in the amount of **₱326,997.83** for the procurement of **ONE (1) LOT SUPPLY OF LABOR, MATERIALS AND TOOLS/EQUIPMENT FOR THE MAINTENANCE OF ESD FIELD OFFICE, ESD FIELD OFFICE-DOOR & WINDOW, POWERHOUSE COMPOUND, PORT OF ZAMBOANGA, ZAMBOANGA CITY (ZAM-330D-2025) WITH AN ABC OF ₱197,776.92.**
