

**PPA, PMO ZAMBOANGA WITH AN APPROVED BUDGET OF CONTRACT (ABC) OF P4,667,565.50.**


- b) To recommend for approval by the Acting Port Manager of the PPA, PMO-Zamboanga, Zamboanga City the foregoing findings.
