**SUPPLY AND DELIVERY OF ONE (1) SET OUTDOOR LED WALL BILLBOARD DISPLAY
FOR PPA, PMO ZAMBOANGA WITH AN ABC OF PHP1,500,000.00**

WHEREAS, the Philippine Ports Authority, PMO Zamboanga, through its Bids and Awards Committee (BAC) and in accordance with the Revised IRR of RA 9184 posted and advertised the Invitation to Bid including the Bidding Documents for the Supply and Delivery of One (1) Set Outdoor LED Wall Billboard Display for PPA, PMO Zamboanga with an ABC of Php1,500,000.00 on December 13, 2021 to January 3, 2022 in the PPA Procurement Webpage, Philippine Government Electronic Procurement System (PhilGEPS), PMO Bulletin Boards;



To recommend for approval by the Port Manager of the PPA, PMO-Zamboanga, Zamboanga City the foregoing findings.


