BAC RESOLUTION DECLARING LOWEST CALCULATED AND RESPONSIVE QUOTATION AND RECOMMENDING APPROVAL

BAC RESOLUTION NO. SVP- 03 - 2019

WHEREAS, the Philippine Ports Authority, PMO-Zamboanga, through its Bids and Awards Committee (BAC) and in accordance with the Revised IRR of RA 9184 under Section 53.9-Small Value Procurement posted the Request for Quotation of “One (1) Lot – Supply of Labor and Materials for the On-Site General Cleaning of Airconditioning Units of PPA, PMO-Zamboanga from April 1 to December 31, 2019 with an Approved Budget for the Contract (ABC) of Php537,000.00 on February 27 to March 7, 2019, in the PPA Website, PhilGEPS Website, and in the PMO Bulletin Boards.

WHEREAS, the BAC sent Request for Quotations (RFQs) to six (6) suppliers, namely: 1) National Commercial; 2) Victorious General Merchandise & Services; 3) Zamboanga Hermosa Service Specialist; 4) N & N Service Center; 5) REE Cooling Services; and 6) EMCOR, Inc.;

WHEREAS, in response to the postings, only three (3) suppliers submitted their bid documents before the deadline, namely: 1) N & N Service Center; 2) REE Cooling Services; and 3) Victorious General Merchandise & Services;

WHEREAS, the BAC opened the sealed price quotation of the said suppliers on March 7, 2019 at 10:00 AM. The result of the opening was described below:

WHEREAS, the BAC declared N & N Service Center as the bidder with the Lowest Calculated and Responsive Quotation in the amount of Php 130,365.00 less than the ABC of Php 537,000.00;

NOW, THEREFORE, We, the Members of the PMO-Zamboanga Bids and Awards Committee, hereby, **RESOLVE**, as it is hereby **RESOLVED**:

- a) To endorse N & N Service Center as the bidder with the Lowest Calculated and Responsive Quotation in the amount of Php 130,365.00 for the One (1) Lot – Supply of Labor and Materials for the On-Site General Cleaning of Airconditioning Units of PPA, PMO-Zamboanga from April 1 to December 31, 2019; and
- b) To recommend for approval by the Port Manager of PPA, PMO-Zamboanga the foregoing findings.
