



**ONE (1) LOT – SUPPLY OF LABOR ONLY FOR THE MINOR REPAIR AND MAINTENANCE SERVICES OF OFFICE MOTOR VEHICLES OF PPA, PMO-ZAMBOANGA FROM APRIL 1 TO DECEMBER 31, 2019**

**BAC RESOLUTION DECLARING LOWEST CALCULATED AND RESPONSIVE QUOTATION AND RECOMMENDING APPROVAL**

**BAC RESOLUTION NO. SVP- 01 - 2019**

WHEREAS, the Philippine Ports Authority, PMO-Zamboanga, through its Bids and Awards Committee (BAC) and in accordance with the Revised IRR of RA 9184 under Section 53.9-Small Value Procurement posted the Request for Quotation of “One (1) Lot – Supply of Labor Only for the Minor Repair and Maintenance Services of Office Motor Vehicles of PPA, PMO-Zamboanga from April 1-December 31, 2019 with an Approved Budget for the Contract (ABC) of Php110,000.00 on February 27 to March 7, 2019, in the PPA Website, PhilGEPS Website, and in the PMO Bulletin Boards.

WHEREAS, the BAC sent Request for Quotations (RFQs) to three (3) suppliers, namely: 1) SG Autoworx, Inc.; 2) La Hermosa Pit Stop Shop and General Merchandise Inc.; and 3) Zambo Tire Square;

WHEREAS, in response to the postings, only La Hermosa Pit Stop Shop and General Merchandise Inc. and Zambo Tire Square submitted their bid documents before the deadline;

WHEREAS, the BAC opened the sealed price quotation of the said suppliers on March 7, 2019 at 10:00 AM. The results were detailed below:

WHEREAS, upon validation of the documents, the result for the same was **RESPONSIVE**;

WHEREAS, the BAC declared La Hermosa Pit Stop Shop and General Merchandise, Inc. as the bidder with the Lowest Calculated and Responsive Quotation in the amount of Php 82,400.00 less than the ABC of Php 110,000.00;

NOW, THEREFORE, We, the Members of the PMO-Zamboanga Bids and Awards Committee, hereby, **RESOLVE**, as it is hereby **RESOLVED**:

- a) To endorse La Hermosa Pit Stop Shop and General Merchandise, Inc. as the bidder with the Lowest Calculated and Responsive Quotation in the amount of Php 82,400.00 for the “One (1) Lot – Supply of Labor Only for the Minor Repair and Maintenance Services of Office Motor Vehicles of PPA, PMO-Zamboanga from April 1-December 31, 2019; and
- b) To recommend for approval by the Port Manager of PPA, PMO-Zamboanga the foregoing findings.


