BAC RESOLUTION DECLARING SINGLE CALCULATED AND RESPONSIVE QUOTATION AND RECOMMENDING APPROVAL

BAC RESOLUTION NO. SVP- 04 - 2019

WHEREAS, the Philippine Ports Authority, PMO-Zamboanga, through its Bids and Awards Committee (BAC) and in accordance with the Revised IRR of RA 9184 under Section 53.9-Small Value Procurement posted the Request for Quotation of "One (1) Lot – Supply of Labor and Materials for the Provision of Various Services such as Photocopy, Blue, White and Colored Print, Binding, Duplo, Auto Cad Printing/Cad Plotting, Tarpaulin and Stickers Printing and Lamination of Signages for PPA, PMO-Zamboanga from April 1-December 31, 2019 with an Approved Budget for the Contract (ABC) of Php375,000.00 on February 27 to March 7, 2019, in the PPA Website, PhilGEPS Website, and in the PMO Bulletin Boards.

WHEREAS, the BAC sent Request for Quotations (RFQs) to three (3) suppliers, namely: 1) Astoria Printing; 2) Ceejay's Enterprises; and 3) Copier Solutions Specialist;

WHEREAS, in response to the postings, only Copier Solution Specialist submitted the bid documents before the deadline;

WHEREAS, the BAC opened the sealed price quotation of the said suppliers on March 7, 2019 at 10:00 AM. The result of the opening was described below:
