**ONE (1) LOT SUPPLY OF PETROLEUM, OIL, LUBRICANT AND OTHER ACCESSORIES TO PPA, PMO-ZAMBOANGA OFFICE MOTOR VEHICLES, GENERATOR SETS, RIGID BUOYANT BOAT FROM MAY 1 TO DECEMBER 31, 2021 WITH AN ABC OF P550,000.00 (PG-ZAM-2021-03-001)**

WHEREAS, the Philippine Ports Authority, PMO-Zamboanga, through its Bids and Awards Committee (BAC) and in accordance with the Revised IRR of RA 9184 posted and advertised the Invitation to Bid including the Bidding Documents for the One (1) Lot Supply of Petroleum, Oil, Lubricant and other accessories to PPA, PMO-Zamboanga office motor vehicles, generator sets, rigid buoyant boat from May 1 to December 31, 2021 on March 15, 2021 to March 22, 2021 in the PPA Procurement Webpage, Philippine Government Electronic Procurement System (PhilGEPS), PMO Bulletin Boards;



- b) To recommend for approval by the Port Manager of the PPA, PMO-Zamboanga, Zamboanga City the foregoing findings.




