



BAC RESOLUTION DECLARING LOWEST CALCULATED AND RESPONSIVE QUOTATION AND RECOMMENDING APPROVAL

BAC RESOLUTION NO. SVP - 02 - 2020

ONE (1) LOT - SUPPLY OF LABOR AND DELIVERY OF PURIFIED DRINKING WATER FOR PPA, PMO-ZAMBOANGA FROM APRIL 1 TO DECEMBER 31, 2020 WITH ABC OF P254,000.00

WHEREAS, the Philippine Ports Authority, PMO-Zamboanga, through its Bids and Awards Committee (BAC) and in accordance with the Revised IRR of RA 9184 posted and advertised the Invitation to Bid including the Bidding Documents for the One (1) Lot - Supply of Labor and Delivery of Purified Drinking Water for PPA, PMO-Zamboanga from April 1 to December 31, 2020 on February 20, 2020 to February 27, 2020 in the PPA Procurement Webpage, Philippine Government Electronic Procurement System (PhilGEPS), PMO Bulletin Boards;

WHEREAS, the BAC sent Request for Quotations (RFQ) to three (3) suppliers, namely: 1.) Z.C. Ultra Pi Refilling Station; 2.) Oceana Drinking Water; and 3.) Hydrate Mary Ann Tan. Out of the three (3) suppliers only two (2) submitted their price quotation.

WHEREAS, the BAC opened the sealed price quotation of the said suppliers on February 27, 2020 at 2:00PM. The results were detailed below:





