AND RECOMMENDING APPROVAL**

**ONE (1) LOT PROVISION OF SNACKS AND/OR LUNCH FOR VARIOUS MEETINGS AND
CONFERENCES OF PPA, PMO-ZAMBOANGA FROM JULY 1 TO DECEMBER 31, 2021
WITH AN ABC OF P324,000.00 (PG-ZAM-03-002)**

WHEREAS, the Philippine Ports Authority, PMO-Zamboanga, through its Bids and Awards Committee (BAC) and in accordance with the Revised IRR of RA 9184 posted and advertised the Invitation to Bid including the Bidding Documents for the One (1) Lot Provision of Snacks and/or Lunch for various meetings and conferences of PPA, PMO-Zamboanga from July 1 to December 31, 2021 on March 15, 2021 to March 22, 2021 in the PPA Procurement Webpage, Philippine Government Electronic Procurement System (PhilGEPS), PMO Bulletin Boards;

WHEREAS, the BAC sent Request for Quotations (RFQ) to three (3) suppliers, namely: 1.) Chinitos Food Service Inc., 2.) Family Fried Chicken Restaurant, and 3.) RF Mariano Catering Services. Out of the three (3) suppliers only two (2) suppliers submitted their quotation envelopes, namely: Chinitos Food Services Inc. and RF Mariano Catering Services.

WHEREAS, the BAC opened the sealed price quotation of the said suppliers on March 22, 2021 at 2:00PM. The results were detailed below:



- b) To recommend for approval by the Port Manager of the PPA, PMO-Zamboanga, Zamboanga City the foregoing findings.


