



BAC RESOLUTION DECLARING LOWEST CALCULATED AND RESPONSIVE QUOTATION AND RECOMMENDING APPROVAL

BAC RESOLUTION NO. SVP-03-2021

ONE (1) LOT SUPPLY AND DELIVERY OF PURIFIED DRINKING WATER FOR PPA, PMO-ZAMBOANGA FROM JULY 1 TO DECEMBER 31, 2021 WITH AN ABC P161,000.00 (PG-ZAM-2021-03-003)

WHEREAS, the Philippine Ports Authority, PMO-Zamboanga, through its Bids and Awards Committee (BAC) and in accordance with the Revised IRR of RA 9184 posted and advertised the Invitation to Bid including the Bidding Documents for the One (1) Lot Supply and Delivery of Purified Drinking Water for PPA, PMO-Zamboanga from July 1 to December 31, 2021 on March 15, 2021 to March 22, 2021 in the PPA Procurement Webpage, Philippine Government Electronic Procurement System (PhilGEPS), PMO Bulletin Boards;

WHEREAS, the BAC sent Request for Quotations (RFQ) to three (3) suppliers, namely: 1.) Oceanah Water Refilling Station; 2.) Nature's Mist Refilling Station, and 3.) ZC Ultra Pi Water Refilling Station. Out of the three (3) suppliers only two (2) submitted their quotation envelopes, namely: Oceanah Water Refilling Station and ZC Ultra Pi Water Refilling Station.

WHEREAS, the BAC opened the sealed price quotation of the said suppliers on March 22, 2021 at 2:00PM. The results were detailed below:





- b) To recommend for approval by the Port Manager of the PPA, PMO-Zamboanga, Zamboanga City the foregoing findings.


