



BAC RESOLUTION DECLARING LOWEST AND RESPONSIVE QUOTATION AND RECOMMENDING APPROVAL

BAC RESOLUTION NO. WP-10-2024

TWENTY (20) UNITS ERGONOMIC CHAIR WITH ARMREST FOR OFFICIAL USE OF PPA, PMO ZAMBOANGA WITH AN ABC OF ₱240,000.00

WHEREAS, the Philippine Ports Authority, PMO Zamboanga, through its Bids and Awards Committee (BAC) and in accordance with the Revised IRR of RA 9184 posted and advertised the Invitation to Bid including the Bidding Documents for the TWENTY (20) UNITS ERGONOMIC CHAIR WITH ARMREST FOR OFFICIAL USE OF PPA, PMO ZAMBOANGA WITH AN ABC OF \$\rightarrow\$240,000.00 on April 5 to 12, 2024, in the PPA Procurement Webpage, Philippine Government Electronic Procurement System (PhilGEPS), PMO Bulletin Boards;

WHEREAS, the procurement is conducted through Negotiated Procurement-Small Value Procurement (Sec. 53.9) and the amount does not exceed the threshold prescribed in Annex H of the IRR;

WHEREAS, the BAC sent Request for Quotation (RFQ) to three (3) suppliers, namely: **ZC Paperline and Computer Stationers**; **ICON Home Depot**, and **RC Lim Marketing**. There were two (2) suppliers that participated through the PhilGEPS Website, namely: **Suntawood Home and Office, Inc.**, and **ZC LM Enterprises**;

WHEREAS, the BAC opened the sealed price quotation of supplier on April 12, 2024, at 2:00PM. The results were as follows:
