ONE (1) LOT SUPPLY OF LABOR AND MATERIALS FOR THE PROVISION OF ONE HUNDRED SIXTY-THREE (163) PIECES SUBLIMATION T-SHIRTS WITH COLLAR OF VARIOUS SIZES FOR PPA, PMO ZAMBOANGA 44TH YEAR ANNIVERSARY DATED JUNE 1, 2021 WITH AN ABC OF P114,100.00

WHEREAS, the Philippine Ports Authority, PMO-Zamboanga, through its Bids and Awards Committee (BAC) and in accordance with the Revised IRR of RA 9184 posted and advertised the Invitation to Bid including the Bidding Documents for the One (1) Lot Supply of Labor and Materials for the Provision of One Hundred Sixty-Three (163) pieces Sublimation T-Shirts with Collar of Various Sizes for PPA, PMO Zamboanga 44th Year Anniversary dated June 1, 2021 with an ABC of P114,100.00 on May 7 to May 14, 2021 in the PPA Procurement Webpage, Philippine Government Electronic Procurement System (PhilGEPS), PMO Bulletin Boards;

WHEREAS, the BAC sent Request for Quotations (RFQ) to three (3) suppliers, namely: 1.) Hezion Ads; 2.) 3Z Printing Shop, and 3.) ZINEX. Out of the three (3) only 3Z Printing Shop and Zhujar Manufacturing Inc. who participated through PhilGEPS posting, submitted their price quotation.

WHEREAS, the BAC opened the sealed price quotation of the said suppliers on May 14, 2021 at 2:00PM. The results were detailed below:

- b) To recommend for approval by the Port Manager of the PPA, PMO-Zamboanga, Zamboanga City the foregoing findings.




