ONE (1) LOT PROVISION OF SNACKS AND PACKED MEALS FOR VARIOUS MEETINGS AND CONFERENCE OF PPA, PMO ZAMBOANGA FROM JUNE 1 TO DECEMBER 31, 2022, WITH AN ABC OF PHP455,000.00

WHEREAS, the Philippine Ports Authority, PMO Zamboanga, through its Bids and Awards Committee (BAC) and in accordance with the Revised IRR of RA 9184 posted and advertised the Invitation to Bid including the Bidding Documents for the One (1) Lot Provision of Snacks and Packed Meals for various meetings and conference of PPA, PMO Zamboanga from June 1 to December 31, 2022, with an ABC of Php455,000.00, on May 10 to 17, 2022 in the PPA Procurement Webpage, Philippine Government Electronic Procurement System (PhilGEPS), PMO Bulletin Boards.

WHEREAS, the BAC sent Request for Quotations (RFQs) to three (3) suppliers, namely 1.) Food Paradise; 2.) Grand Astoria Hotel, and 3.) Seafood House.

WHEREAS, the BAC opened the sealed price quotation of the said suppliers on May 17, 2022, at 2:00PM. The results were detailed below:
