***BAC Resolution Declaring Single/Lowest Calculated and Responsive Bid (LCRB)
and Recommending Approval***

BAC RESOLUTION NO. ZAM-PGEPSCS-02-2022

WHEREAS, the Philippine Ports Authority, PMO-Zamboanga, through its Bids and Awards Committee (BAC) and in accordance with the Revised IRR of RA 9184 posted and advertised the Invitation to Bid and Bidding Documents for the project re: **ZAM-PGEPSCS-02-2022 / EP-02-2022 Construction of Dita Community Port, Brgy. Dita, Zamboanga City** in the amount of **Twenty-Nine Million Four Hundred Twelve Thousand Two Hundred Eight & 01/100 Pesos (Php29,407,315.54)** as the **Approved Budget for the Contract (ABC)** on March 8, 2022 up to the submission of bids on April 1, 2022 on or before 10:00 AM in the PPA Website, Philippine Government Electronic Procurement System (PhilGEPS), and PMO-Zamboanga Bulletin Board;

WHEREAS, in response to the said advertisements, only **MAJDA Construction & Development** signified their intention to participate in the public bidding of the above-mentioned project and purchased the bidding documents;

WHEREAS, the BAC conducted a Pre-Bid Conference on March 17, 2022 discussing among others the eligibility, technical and financial requirements of the project to be bid pursuant to Section 22 of the RA 9184;

WHEREAS, in the Submission and Receipt of Bids on April 1, 2022, The BAC Secretariat received one big envelope from **MAJDA Construction & Development** on April 1, 2022 at 8:30 A.M.;

WHEREAS, the BAC opened the Technical Bid Envelope of **MAJDA Construction & Development** and checked each item of the technical documents against a checklist using a non-discretionary "pass/fail" criterion. The BAC found the technical documents as sufficient pursuant to **ITB Clause 10. Documents Comprising the Bid: Eligibility and Technical Components** and rated as "PASSED";

WHEREAS, the BAC proceeded to open the Financial Bid Envelope of **MAJDA Construction & Development** and checked its financial documents against the requirements prescribed in **ITB Clause 11. Documents Comprising the Bid: Financial Component**. The BAC found the financial documents as sufficient and rated "PASSED". The Chairperson announced the Bid Amount of **MAJDA Construction & Development** as **Php29,305,213.93** which is lower than the ABC;

WHEREAS, the BAC conducted the Bid Evaluation on April 4, 2022, after **MAJDA Construction & Development** passed the technical and financial bids requirements pursuant to **ITB Clause 19. Opening and Preliminary Examination of Bids**, to determine the Lowest Calculated Bid;

WHEREAS, in the bid evaluation, the BAC established the correct calculated bid amount of **MAJDA Construction & Development** which is in the amount of **Php29,305,167.04** still less than the ABC;

WHEREAS, the BAC determined **MAJDA Construction & Development** as the Single/Lowest Calculated Bid in the amount of **Php29,305,167.04**;

WHEREAS, the BAC prepared the Abstract of Bids showing **MAJDA Construction & Development** as the Single/Lowest Calculated Bid;


WHEREAS, after the bid has been received, opened, examined, and evaluated, the BAC declare the **BID OF MAJDA Construction & Development as the Single/Lowest Calculated Bid in the amount of Php29,305,167.04;**

WHEREAS, upon post-qualification conducted on April 11-13, 2022 on the submitted eligibility, technical and financial documents of **MAJDA Construction & Development**, the result of Post-Qualification was **RESPONSIVE;**

NOW THEREFORE, We, the Members of the PMO-Zamboanga Bids and Awards Committee, hereby RESOLVE as it is hereby RESOLVED:

- a) To declare the bid of **MAJDA Construction & Development** as the **SINGLE/LOWEST CALCULATED AND RESPONSIVE BID** for the project: **Construction of Dita Community Port, Brgy. Dita, Zamboanga City** in the Amount of **Php29,305,167.04.**
- b) To recommend for approval by the Port Manager of the PPA, PMO-Zamboanga, Zamboanga City the foregoing findings.
