BAC Resolution Declaring Lowest Calculated and Responsive Quotation (LCRQ) and Recommending Approval

BAC RESOLUTION NO.: SVP-06-2022

WHEREAS, the Philippine Ports Authority, PMO-Zamboanga, through its Bids and Awards Committee (BAC) and in accordance with the Revised IRR of RA 9184 posted and advertised the Request for Quotation for the project: **One (1) Lot Supply of Labor Materials and Equipment for “Fabrication of Office Cubicle /Partitions at the Conference Room for use of the Administrative Division Personnel, PPA, PMO-Zamboanga”, Port of Zamboanga, Zamboanga City** in the amount of **Nine Hundred Eighty-Eight Thousand Nine Hundred Seventy-Five & 00/100 Pesos (Php988,975.00)** as the **Approved Budget for the Contract (ABC)** on May 16, 2022 up to the submission of bids on May 24, 2022 in the PPA Website, Philippine Government Electronic Procurement System (PhilGEPS), and PMO-Zamboanga Bulletin Board;

WHEREAS, the BAC sent the Request for Quotation (RFQ) to three (3) Suppliers namely: 1. **Trending Products Inc.** on May 16, 2022, 2. **Filipinas Builders** on May 17, 2022, and 3. **Z.C.Filipinas Furniture** on May 18, 2022.

WHEREAS, in response to PPA Website and PhilGEPS publication the BAC Secretariat received an envelope from **Z.C.Filipinas Furniture** on May 24, 2022 at 8:45 A.M.

WHEREAS, during the opening of price quotation on May 24, 2022, the envelope of **Z.C.Filipinas Furniture** was opened and checked each item of the eligibility documents against a checklist using a non-discretionary “pass/fail” criterion. The BAC found the eligibility documents as sufficient pursuant to **Annex H, Section F of the Republic Act 9184** and rated as “PASSED”;

WHEREAS, the Chairperson proceeded to announce the price quoted as **Read** of **Z.C.Filipinas Furniture** in the prescribed canvass form in the amount of **Php988,975.00** equal to the ABC of **Php988,975.00**;

WHEREAS, the BAC conducted the Bid Evaluation on May 25, 2022 and proceed to evaluate the price quotation of **Z.C.Filipinas Furniture** and found no computational errors on the prices quoted in the prescribed canvass form.

WHEREAS, the BAC determined **Z.C.Filipinas Furniture** as the Single/Lowest Calculated and Responsive Quotation in the amount of **Php988,975.00**;

WHEREAS, the BAC prepared the Abstract of Price Quotation showing **Z.C.Filipinas Furniture** as the Lowest Calculated and Responsive Quotation;

WHEREAS, after the price quotation has been received, opened, examined, and evaluated, the BAC declared the **PRICE QUOTATION OF Z.C.FILIPINAS FURNITURE AS THE SINGLE/LOWEST CALCULATED AND RESPONSIVE QUOTATION in the amount of Php988,975.00;**

NOW THEREFORE, We, the Members of the PMO-Zamboanga Bids and Awards Committee, hereby RESOLVE as it is hereby RESOLVED:

- a) To declare the bid of **Z.C.FILIPINAS FURNITURE** as the **SINGLE/LOWEST CALCULATED AND RESPONSIVE QUOTATION** for the Project: **ONE (1) LOT SUPPLY OF LABOR MATERIALS AND EQUIPMENT FOR "FABRICATION OF OFFICE CUBICLE /PARTITIONS AT THE CONFERENCE ROOM FOR USE OF THE ADMINISTRATIVE DIVISION PERSONNEL, PPA, PMO-ZAMBOANGA", PORT OF ZAMBOANGA, ZAMBOANGA CITY** in the Amount of **Php988,975.00**.
- b) To recommend for approval by the Port Manager of the PPA, PMO-Zamboanga, Zamboanga City the foregoing findings.


