



BAC RESOLUTION DECLARING FAILURE OF BIDDING

BAC RESOLUTION NO. JVP-16-2023

ONE (1) LOT SUPPLY OF MATERIALS FOR THE EMERGENCY PROVISION OF ELECTRICAL WIRINGS/LIGHTING FIXTURES AT VARIOUS PHYSICAL FACILITIES, HALFWAY HOUSE COMPOUND, PORT OF ZAMBOANGA, ZAMBOANGA CITY WITH AN ABC OF PHP119,522.40

WHEREAS, the Philippine Ports Authority, PMO Zamboanga, through its Bids and Awards Committee (BAC) and in accordance with the Revised IRR of RA 9184 posted and advertised the Invitation to Bid including the Bidding Documents for the One (1) Lot Supply of Materials for the Emergency Provision of Electrical Wirings/Lighting Fixtures at Various Physical Facilities, Halfway House Compound, Port of Zamboanga, Zamboanga City with an ABC of Php119,522.40 on May 29, 2023 to June 5, 2023 in the PPA Procurement Webpage, Philippine Government Electronic Procurement System (PhilGEPS), PMO Bulletin Boards;

WHEREAS, the procurement is conducted through Negotiated Procurement-Small Value Procurement (Sec. 53.9) and the amount does not exceed the threshold prescribed in Annex H of the IRR;

WHEREAS, the BAC opened the sealed price quotation of supplier on June 5, 2023, at 2:00PM. The results were as follows:

1	Electron Comtronics and Service Center	Php147,384.00	Automatic Disqualification because the quoted amount is higher than the ABC of Php119,522.40.




