



BAC RESOLUTION DECLARING FAILURE OF BIDDING

ONE (1) LOT SUPPLY AND DELIVERY OF PURIFIED DRINKING WATER IN ROUND CONTAINERS AND BOTTLED WATER FOR PPA, PMO ZAMBOANGA FROM JULY 1 TO DECEMBER 31, 2022, WITH AN ABC OF PHP161,930.00

WHEREAS, the Philippine Ports Authority, PMO Zamboanga, through its Bids and Awards Committee (BAC) and in accordance with the Revised IRR of RA 9184 posted and advertised the Invitation to Bid including the Bidding Documents for the One (1) Lot Supply and Delivery of Purified Drinking Water in Round Containers and Bottled Water for PPA, PMO Zamboanga from July 1 to December 31, 2022, with an ABC of Php161,930.00, on May 27 to June 3, 2022 in the PPA Procurement Webpage, Philippine Government Electronic Procurement System (PhilGEPS), PMO Bulletin Boards.

WHEREAS, the BAC sent Request for Quotations (RFQs) to three (3) suppliers, namely 1.) Oceanah Water Refilling Station; 2.) Royal Blue Water Refilling Station, and 3.) Agua 2Go.

WHEREAS, the BAC declared Oceanah Water Refilling Station as a non-responsive bidder with due to the non-submission of Income Tax Return for CY 2021;




