



BAC RESOLUTION DECLARING FAILURE OF BIDDING

ONE (1) LOT SUPPLY AND DELIVERY OF VARIOUS MATERIALS FOR THE REPAIR/REPLACEMENT OF FLOOR TILES AT THE PORT MANAGER'S QUARTER AND LOUNGE ROOM AT THE OFFICE OF THE PORT MANAGER WITH AN ABC OF PHP129,614.24

WHEREAS, the Philippine Ports Authority, PMO Zamboanga, through its Bids and Awards Committee (BAC) and in accordance with the Revised IRR of RA 9184 posted and advertised the Invitation to Bid including the Bidding Documents for the One (1) Lot Supply and Delivery of Various Materials for the Repair/replacement of Floor Tiles at the Port Manager's Quarter and Lounge Room at the Office of the Port Manager with an ABC of Php129,614.24, on May 27 to June 3, 2022 in the PPA Procurement Webpage, Philippine Government Electronic Procurement System (PhilGEPS), PMO Bulletin Boards.

WHEREAS, the BAC sent Request for Quotations (RFQs) to three (3) suppliers, namely 1.) Wilcon Depot Inc.; 2.) Expo Home Depot Inc., and 3.) ZC MSL Builders and Home Depot.

WHEREAS, the BAC opened the sealed price quotation of the said suppliers on June 3, 2022, at 2:00PM. The results were detailed below:
