**ONE (1) LOT SUPPLY OF LABOR AND MATERIALS FOR THE ON-SITE GENERAL
CLEANING OF AIRCONDITIONING UNITS OF PPA, PMO ZAMBOANGA, ZAMBOANGA
CITY FROM JULY 1 TO DECEMBER 31, 2021**

WHEREAS, the Philippine Ports Authority, PMO Zamboanga, through its Bids and Awards Committee (BAC) and in accordance with the Revised IRR of RA 9184 posted and advertised the Invitation to Bid including the Bidding Documents for the One (1) Lot Supply of Labor and Materials for the On-Site General Cleaning of Airconditioning Units of PPA, PMO Zamboanga, Zamboanga City from July 1 to December 31, 2021 on May 27 to June 3, 2021 in the PPA Procurement Webpage, Philippine Government Electronic Procurement System (PhilGEPS), PMO Bulletin Boards;

WHEREAS, the BAC sent Request for Quotations (RFQ) to three (3) suppliers, namely 1.) Marzky Refcon Service Center; 2.) N & N Service Center, 3.) Victorious General Merchandise and Services. Out of the three (3) only N & N Service Center and Marzky Refcon Service Center submitted their price quotation.

WHEREAS, the BAC opened the sealed price quotation of the said suppliers on June 3, 2021 at 2:00PM. The results were detailed below:

- b) To recommend for approval by the Port Manager of the PPA, PMO-Zamboanga, Zamboanga City the foregoing findings.


