

**BAC RESOLUTION DECLARING LOWEST CALCULATED AND RESPONSIVE QUOTATION AND RECOMMENDING APPROVAL**

**BAC RESOLUTION NO. SVR-17-2021**

**ONE (1) LOT SUPPLY OF LABOR AND MATERIALS FOR THE PROVISION OF VARIOUS SERVICES SUCH AS PHOTOCOPY, BLUE AND WHITE PRINTING, BINDING, DUPLO/RISO PRINTING, COLORED PRINTING; AUTOCAD PLOTTING, TARPAULIN PRINTING, NOTED PAD AND CALLING CARD PRINTING AND FABRICATION OF TEMPORARY VEHICLE PLATE FOR THE OFFICIAL SERVICE VEHICLE OF PPA, PMO ZAMBOANGA FROM JULY 1 TO DECEMBER 31, 2021**

WHEREAS, the Philippine Ports Authority, PMO Zamboanga, through its Bids and Awards Committee (BAC) and in accordance with the Revised IRR of RA 9184 posted and advertised the Invitation to Bid including the Bidding Documents for the One (1) Lot Supply of Labor and Materials for the Provision of Various Services such as Photocopy, Blue and White Printing, Binding, Duplo/Riso Printing, Colored Printing, AutoCad Plotting, Tarpaulin Printing, Noted Pad and Calling Card Printing and Fabrication of Temporary Vehicle Plate for the Official Service Vehicle of PPA, PMO Zamboanga from July 1 to December 31, 2021 on May 27 to June 3, 2021 in the PPA Procurement Webpage, Philippine Government Electronic Procurement System (PhilGEPS), PMO Bulletin Boards;

WHEREAS, the BAC sent Request for Quotations (RFQ) to three (3) suppliers, namely 1.) Ceejays Enterprises; 2.) Copier Solutions Specialist, and 3.) Vistas Design and Ads. Out of the three (3) only Copier Solutions Specialist and Vistas Design and Ads submitted their price quotation.

WHEREAS, the BAC opened the sealed price quotation of the said suppliers on June 3, 2021 at 2:00PM. The results were detailed below:


