



**BAC RESOLUTION DECLARING LOWEST CALCULATED AND RESPONSIVE QUOTATION
AND RECOMMENDING APPROVAL**

**ONE (1) LOT SUPPLY OF LABOR ONLY FOR THE MINOR REPAIR AND MAINTENANCE
SERVICES OF OFFICE MOTOR VEHICLES OF PPA, PMO ZAMBOANGA FROM JULY 1 TO
DECEMBER 31, 2021**

WHEREAS, the Philippine Ports Authority, PMO Zamboanga, through its Bids and Awards Committee (BAC) and in accordance with the Revised IRR of RA 9184 posted and advertised the Invitation to Bid including the Bidding Documents for the One (1) Lot Supply of Labor only for the minor repair and maintenance services of office motor vehicles of PPA, PMO Zamboanga from July 1 to December 31, 2021 on June 3, 2021 to June 10, 2021 in the PPA Procurement Webpage, Philippine Government Electronic Procurement System (PhilGEPS), PMO Bulletin Boards;

WHEREAS, the BAC sent Request for Quotations (RFQ) to four (4) suppliers, namely 1.) SGA Autoworx Inc.; 2.) La Hermosa Pitstop Shop, 3.) Talab Auto Repair Shop and 4.) Maenograf Auto Service Center. Out of the four (4) only Maenograf Auto Service Center and Talab Auto Repair Shop submitted their price quotation.

WHEREAS, the BAC opened the sealed price quotation of the said suppliers on June 10, 2021 at 2:00PM. The results were detailed below:



- b) To recommend for approval by the Port Manager of the PPA, PMO-Zamboanga, Zamboanga City the foregoing findings.


