**ONE (1) LOT SUPPLY OF MATERIALS FOR THE "EMERGENCY PROVISION OF ELECTRICAL WIRINGS/LIGHTING FIXTURES AT VARIOUS PHYSICAL FACILITIES" AT PORT OF ZAMBOANGA, ZAMBOANGA CITY.**

WHEREAS, the Philippine Ports Authority, PMO Zamboanga, through its Bids and Awards Committee (BAC) and in accordance with the Revised IRR of RA 9184 posted and advertised the Invitation to Bid including the Bidding Documents for the One (1) Lot Supply of Materials for the "Emergency Provision of Electrical Wirings/Lighting Fixtures at Various Physical Facilities" at Port of Zamboanga, Zamboanga City. on May 17 to May 24, 2021 in the PPA Procurement Webpage, Philippine Government Electronic Procurement System (PhilGEPS), PMO Bulletin Boards;

WHEREAS, the BAC sent Request for Quotations (RFQ) to four (4) suppliers, namely 1.) Dennis Hardware Enterprises Inc.; 2.) Pacific Hardware, 3.) Victorious General Merchandise and Services and 4.) Janlee Trading Complex. Out of the four (4) only Zamboanga JA Trading Corp.-Pacific Hardware, submitted their price quotation.

WHEREAS, the BAC opened the sealed price quotation of the said suppliers on May 27, 2021 at 10:00AM. The results were detailed below:


