



BAC RESOLUTION DECLARING LOWEST CALCULATED AND RESPONSIVE QUOTATION AND RECOMMENDING APPROVAL

ONE (1) LOT SUPPLY OF MATERIALS FOR THE "EMERGENCY REPAIR OF MOVABLE STEEL FENCES/STEEL BARRIER, AND VARIOUS PHYSICAL FACILITIES" AT THE PORT OF ZAMBOANGA, ZAMBOANGA CITY

WHEREAS, the Philippine Ports Authority, PMO Zamboanga, through its Bids and Awards Committee (BAC) and in accordance with the Revised IRR of RA 9184 posted and advertised the Invitation to Bid including the Bidding Documents for the One (1) Lot Supply of Materials for the "Emergency Repair of Movable Steel Fences/Steel Barrier, and Various Physical Facilities" at the Port of Zamboanga, Zamboanga City on May 17 to May 24, 2021 in the PPA Procurement Webpage, Philippine Government Electronic Procurement System (PhilGEPS), PMO Bulletin Boards;

WHEREAS, the BAC sent Request for Quotations (RFQ) to four (4) suppliers, namely 1.) Dennis Hardware Enterprises Inc.; 2.) Pacific Hardware, 3.) Nationwide Sales Corp. and 4.) Janlee Trading. Out of the four (4) only Zamboanga JA Trading Corp.-Pacific Hardware, submitted their price quotation.

WHEREAS, the BAC opened the sealed price quotation of the said suppliers on May 25, 2021 at 10:00AM. The results were detailed below:




