**ONE (1) LOT SUPPLY OF LABOR AND DELIVERY OF VARIOUS MATERIALS FOR THE REPAIR/REPLACEMENT OF FLOOR TILES AT THE PORT MANAGER'S QUARTER AND LOUNGE ROOM AT THE OFFICE OF THE PORT MANAGER WITH AN ABC OF PHP184,145.00**

WHEREAS, the Philippine Ports Authority, PMO Zamboanga, through its Bids and Awards Committee (BAC) and in accordance with the Revised IRR of RA 9184 posted and advertised the Invitation to Bid including the Bidding Documents for the One (1) Lot Supply of Labor and Delivery of Various Materials for the Repair/Replacement of Floor Tiles at the Port Manager's Quarter and Lounge Room at the Office of the Port Manager with an ABC of Php184,145.00, on June 28 to July 5, 2022 in the PPA Procurement Webpage, Philippine Government Electronic Procurement System (PhilGEPS), PMO Bulletin Boards.

WHEREAS, the BAC sent Request for Quotations (RFQs) to three (3) suppliers, namely 1.) Dennis Hardware and Enterprise Inc.; 2.) Expo Home Depot Corp., and 3.) Homestyle Depot. Only one (1) submitted their price quotation including SSR Construction and Enterprise which participated through PhilGEPS Website posting. Below is the result of the proceedings.

WHEREAS, the BAC opened the sealed price quotation of the said suppliers on July 5, 2022, at 2:00PM. The results were detailed below:



To recommend for approval by the Port Manager of the PPA, PMO-Zamboanga, Zamboanga City the foregoing findings.




