



BAC RESOLUTION DECLARING LOWEST CALCULATED AND RESPONSIVE QUOTATION AND RECOMMENDING APPROVAL

ONE (1) LOT – SUPPLY AND DELIVERY OF SIX (6) UNITS COMPUTER MONITOR, LED 23 INCHES, ANTI-GLARE (MATTE) FOR PPA, PMO-ZAMBOANGA

WHEREAS, the Philippine Ports Authority, PMO-Zamboanga, through its Bids and Awards Committee (BAC) and in accordance with the Revised IRR of RA 9184 under Section 53.9-Small Value Procurement posted the Request for Quotation of “One (1) Lot – Supply and Delivery of Six (6) Units Computer Monitor, LED 23 inches, Anti-Glare (Matte) for PPA, PMO-Zamboanga” with an Approved Budget for the Contract (ABC) of Php 90,000.00 on June 3-11, 2019, in the PPA Website, PhilGEPs Website, and PMO Bulletin Boards;
