



**BAC RESOLUTION DECLARING LOWEST CALCULATED AND RESPONSIVE QUOTATION AND
RECOMMENDING APPROVAL**

BAC RESOLUTION NO. SVP- 05 - 2019

**ONE (1) LOT – SUPPLY, DELIVERY, AND INSTALLATION OF ONE (1) UNIT DIGITAL COLOR
COPIER MACHINE**

WHEREAS, the Philippine Ports Authority, PMO-Zamboanga, through its Bids and Awards Committee (BAC) and in accordance with the Revised IRR of RA 9184 under Section 53.9-Small Value Procurement posted the Request for Quotation of "One (1) Lot – Supply, Delivery, and Installation of One (1) Unit Digital Color Copier Machine with an Approved Budget for the Contract (ABC) of Php140,000.00 on May 9-17, 2019, in the PPA Website, PhilGEPs Website, and PMO Bulletin Boards;

WHEREAS, the BAC sent Request for Quotations (RFQs) to three (3) suppliers, namely: 1) Copylandia Office Systems Corporation; 2) Philcopy Corporation; and 3) Ceejay's Enterprises;

WHEREAS, in response to the postings, only Copylandia Office Systems Corporation and Philcopy Corporation submitted their bid documents before the deadline;

WHEREAS, the BAC opened the sealed price quotation of the said suppliers on May 17, 2019 at 10:00 AM. The results were detailed below:

WHEREAS, the bid documents submitted by Copylandia Office Systems Corporation which was considered as the bidder with the Lowest Price Quotation shall be subject to validation;

WHEREAS, however, upon validation of the documents, the BAC found out that Copylandia Office System Corporation was non-compliant and ineligible for failure to meet the required product specification;

WHEREAS, the second lowest bidder, Philcopy Corporation, was subjected to validation of its submitted documents and the BAC found the same to be compliant and eligible;

WHEREAS, the BAC declared Philcopy Corporation as the bidder with the Lowest Calculated and Responsive Quotation in the amount of Php 140,000.00 equal to the ABC of Php 140,000.00;

NOW, THEREFORE, We, the Members of the PMO-Zamboanga Bids and Awards Committee, hereby, RESOLVE, as it is hereby RESOLVED:


- a) To endorse Philcopy Corporation as the bidder with the Lowest Calculated and Responsive Quotation in the amount of Php 140,000.00 for the "One (1) Lot – Supply, Delivery, and Installation of One (1) Unit Digital Color Copier Machine; and
- b) To recommend for approval by the Port Manager of PPA, PMO-Zamboanga the foregoing findings.
