

RECOMMENDING APPROVAL

BAC RESOLUTION NO. SVP- 06 - 2019

**ONE (1) LOT – SUPPLY AND DELIVERY OF FIFTY-FIVE (55) UNITS EXECUTIVE SWIVEL CHAIR, LOW BACK, COLOR BLACK WITH MESH, HEAVY DUTY, SIZE: 650W X 490D X 1120-1155H**

WHEREAS, the Philippine Ports Authority, PMO-Zamboanga, through its Bids and Awards Committee (BAC) and in accordance with the Revised IRR of RA 9184 under Section 53.9-Small Value Procurement posted the Request for Quotation of "One (1) Lot – Supply And Delivery Of Fifty Five (55) Units Executive Swivel Chair, Low Back, Color Black With Mesh, Heavy Duty, Size: 650w X 490d X 1120-1155h" with an Approved Budget for the Contract (ABC) of Php 900,000.00 on May 9-17, 2019, in the PPA Website, PhilGEPS Website, and PMO Bulletin Boards;

WHEREAS, the BAC sent Request for Quotations (RFQs) to three (3) suppliers, namely: 1) Z.C. LM Enterprises; 2) Z.C Filipinas Furniture; and 3) PC User's Shop;

WHEREAS, aside from the above-mentioned suppliers, other suppliers also participated and submitted their price quotation envelopes, namely: 1) Filcrafters, Incorporated; 2) Jacsons' Enterprises Corporation; 3) MYZ Alta Muebles Enterprises, and 4) SEE Manufacturing Contractor submitted their bid documents before the deadline;

WHEREAS, the BAC opened the sealed price quotation of the said suppliers on May 17, 2019 at 10:00 AM. The results were detailed below:

WHEREAS, since only two (2) suppliers, Z.C. Filipinas Furniture and MYZ Alta Muebles Enterprises, were considered eligible and the remaining six (6) suppliers were non-compliant and ineligible for failure to meet the required product specification, the BAC declared Z.C. Filipinas Furniture as the Lowest Calculated and Responsive Quotation in the amount of Php 739,200.00 less than the ABC of Php900,000.00;


