ONE (1) LOT SUPPLY AND DELIVERY OF THIRTY-SIX (36) UNITS CABINET MADE OF STEEL AND HEAVY DUTY FOR PPA, PMO ZAMBOANGA

WHEREAS, the Philippine Ports Authority, PMO Zamboanga, through its Bids and Awards Committee (BAC) and in accordance with the Revised IRR of RA 9184 posted and advertised the Invitation to Bid including the Bidding Documents for the One (1) Lot Supply and Delivery of Thirty-Six (36) units Cabinet made of steel and heavy duty for PPA, PMO Zamboanga on June 3, 2021 to June 10, 2021 in the PPA Procurement Webpage, Philippine Government Electronic Procurement System (PhilGEPS), PMO Bulletin Boards;

WHEREAS, the BAC sent Request for Quotations (RFQ) to four (4) suppliers, namely 1.) ZC Paperline & Computer Stationers; 2.) RC Lim Marketing; 3.) Z.C.Filipinas Furnitures and 4.) ZC LM Enterprises. All of the four (4) submitted their price quotations. Periton Trading of Caloocan City, which participated through the PhilGEPS Notice also submitted their quotation.

- b) To recommend for approval by the Port Manager of the PPA, PMO-Zamboanga, Zamboanga City the foregoing findings.


