



BAC RESOLUTION DECLARING LOWEST CALCULATED AND RESPONSIVE QUOTATION AND RECOMMENDING APPROVAL

BAC RESOLUTION NO. SVP- 04 - 2019

ONE (1) LOT – SUPPLY OF LABOR AND MATERIALS FOR THE INSTALATION OF FIFTY-THREE (53) PANELS COMBI BLINDS, MANDY, COLOR BEIGE, FABRIC MADE WITH CRYSTAL CHAIN FOR PPA, PMO-ZAMBOANGA

WHEREAS, the Philippine Ports Authority, PMO-Zamboanga, through its Bids and Awards Committee (BAC) and in accordance with the Revised IRR of RA 9184 under Section 53.9-Small Value Procurement posted the Request for Quotation of “One (1) Lot – Supply of Labor and Materials for the Installation of Fifty-Three (53) Panels Combi Blinds, Mandy, Color Beige, Fabric Made with Crystal Chain for PPA, PMO-Zamboanga” with an Approved Budget for the Contract (ABC) of Php 320,000.00 on June 3-11, 2019, in the PPA Website, PhilGEPS Website, and PMO Bulletin Boards;

WHEREAS, the BAC sent Request for Quotations (RFQs) to three (3) suppliers, namely: 1) Citi Glass Supply; 2) RC Lim Marketing; and 3) ZC Filipinas Furniture;

WHEREAS, of the three (3) suppliers, only RC Lim Marketing and ZC Filipinas Furniture submitted their price quotation envelopes;

WHEREAS, aside from the above-mentioned suppliers, other suppliers also participated and submitted their price quotation envelopes before the deadline, namely: 1) MJ Interior Solutions; and 2) Fort Home Decors;

WHEREAS, the BAC opened the sealed price quotation of the said suppliers on June 11, 2019 at 10:00 AM. The results were detailed below:




