AND RECOMMENDING APPROVAL**

ONE (1) LOT SUPPLY OF LABOR & MATERIALS FOR PRINTING SERVICES AND OTHER VARIOUS SERVICES SUCH AS PHOTOCOPY, BLUE AND WHITE PRINTING, BINDING, RISO/DUPLO PRINTING, COLORED PRINTING, CAD PLOTTING, TARPAULIN PRINTING, NOTEPAD AND CALLING CARD PRINTING, PRINTING OS SIGNAGE ON ACRYLIC BOARD, BROCHURE, SINTRA BOARD AND FABRICATION OF TEMPORARY CAR PLATE FOR THE OFFICIAL SERVICE VEHICLE OF PPA, PMO-ZAMBOANGA FROM AUGUST 1, 2024 TO DECEMBER 31, 2024, WITH AN ABC ₱401,020.00.

WHEREAS, the Philippine Ports Authority, PMO Zamboanga, through its Bids and Awards Committee (BAC) and in accordance with the Revised IRR of RA 9184 posted and advertised the Invitation to Bid including the Bidding Documents for the **ONE (1) SUPPLY OF LABOR & MATERIALS FOR PRINTING SERVICES AND OTHER VARIOUS SERVICES SUCH AS PHOTOCOPY, BLUE AND WHITE PRINTING, BINDING, RISO/DUPLO PRINTING, COLORED PRINTING, CAD PLOTTING, TARPAULIN PRINTING, NOTEPAD AND CALLING CARD PRINTING, PRINTING OS SIGNAGE ON ACRYLIC BOARD, BROCHURE, SINTRA BOARD AND FABRICATION OF TEMPORARY CAR PLATE FOR THE OFFICIAL SERVICE VEHICLE OF PPA, PMO-ZAMBOANGA FROM AUGUST 1, 2024 TO DECEMBER 31, 2024, WITH AN ABC ₱401,020.00.** on July 10 to 16, 2024 in the PPA Procurement Webpage, Philippine Government Electronic Procurement System (PhilGEPS), PMO Bulletin Boards;

WHEREAS, the procurement is conducted through Negotiated Procurement-Small Value Procurement (Sec. 53.9) and the amount does not exceed the threshold prescribed in Annex H of the IRR;

WHEREAS, the BAC sent RFQs to the three (3) suppliers, namely: Astoria Printing, Freedom Commercial Printers and Vista's Designs and Ads, but received only one (1) quotation envelope from Vistas Designs and Ads. Another supplier, Copier Solutions Specialist responded through email by submitting its eligibility and financial quotation documents before the said deadline;

WHEREAS, the BAC opened the envelopes of the participating suppliers on July 16, 2024, at 2:00 PM. The results were as follows:
