**BAC RESOLUTION DECLARING SINGLE CALCULATED AND RESPONSIVE QUOTATION AND
RECOMMENDING APPROVAL**

BAC RESOLUTION NO. SVP-06 - 2018

WHEREAS, the Philippine Ports Authority, PMO-Zamboanga, through its Bids and Awards Committee (BAC) and in accordance with the Revised IRR of RA 9184 under Section 53.9-Small Value Procurement posted the Request for Quotation (RFQ) for the "One (1) Lot Supply, Delivery and Installation of one (1) unit Photocopier" with ABC of Php125,000.00 from May 7-14, 2018, in the PPA Website, PhilGEPS Website, and PPA-PMO Bulletin Boards;

WHEREAS, RFQs were sent to three (3) suppliers, namely: 1) Canon Regional Business Partner; 2) Z.C. LM Enterprises; and 3) Philcopy Corporation.

WHEREAS, out of the three (3) suppliers, only Philcopy Corporation, submitted its Price Quotation Envelopes before the deadline on May 8, 2018 at 1:20 PM;

WHEREAS, the BAC opened the envelopes of Philcopy Corporation on May 21, 2018 at 10:00 AM containing the Technical and Financial Requirements;

WHEREAS, the submitted technical documents were checked and found compliant, and rated as "Passed". The financial documents were checked and evaluated, and the Price Quotation was announced by the Chairperson as Php106,000.00 less than the ABC of Php125,000.00;

WHEREAS, upon validation on the documentary requirements of Philcopy Corporation, the BAC found the Technical and Financial documents as responsive;

WHEREAS, the BAC declared the Price Quotation of Philcopy Corporation as the Single Calculated and Responsive Quotation for the One (1) Lot Supply, Delivery and Installation of one (1) unit Photocopier of PMO-Zamboanga;

NOW, THEREFORE, We, the Members of the PMO-Zamboanga Bids and Awards Committee, hereby, RESOLVE, as it is hereby RESOLVED:

- 1) To endorse Philcopy Corporation as the Supplier with the Single Calculated and Responsive Quotation for the One (1) Lot – Supply, Delivery, and Installation of One (1) Unit Photocopier in the amount of Php 106,000.00; and
- 2) To recommend for approval by the Port Manager of PPA, PMO-Zamboanga the foregoing findings.


