**ONE (1) LOT SUPPLY AND DELIVERY OF VARIOUS ELECTRICAL MATERIALS FOR THE
MAINTENANCE OF VARIOUS FACILITIES OF PPA, PMO ZAMBOANGA WITH AN ABC OF
247,400.00**

WHEREAS, the Philippine Ports Authority, PMO Zamboanga, through its Bids and Awards Committee (BAC) and in accordance with the Revised IRR of RA 9184 posted and advertised the Invitation to Bid including the Bidding Documents for the One (1) Lot Supply and Delivery of Various Electrical Materials for the Maintenance of Various Facilities of PPA, PMO Zamboanga with an ABC of 247,400.00, on August 18 to 25, 2022 in the PPA Procurement Webpage, Philippine Government Electronic Procurement System (PhilGEPS), PMO Bulletin Boards.

WHEREAS, the BAC sent Request for Quotations (RFQs) to three (3) suppliers, namely 1.) Asiatic Trading Corp., 2.) Alex Enterprises, and 3.) Victorious General Merchandise. Out of the three (3) only two (2) submitted their price quotations.

WHEREAS, the BAC opened the sealed price quotation of the said suppliers on August 25, 2022, at 2:00PM. The results were as follows:

To recommend for approval by the Port Manager of the PPA, PMO-Zamboanga, Zamboanga City the foregoing findings.




