WHEREAS, the Philippine Ports Authority, PMO Zamboanga, through its Bids and Awards Committee (BAC) and in accordance with the Revised IRR of RA 9184 posted and advertised the Invitation to Bid including the Bidding Documents for the One (1) Lot Supply of Materials and Equipment for the Removal and Replacement of Reported Dilapidated Gutter, Roofing Sheet and Ceiling Panel at PTS Building, TMI Isabela, Port of Isabela, Basilan Province with an ABC of Php67,105.82, on August 18 to 25, 2022 in the PPA Procurement Webpage, Philippine Government Electronic Procurement System (PhilGEPS), PMO Bulletin Boards.
