RECOMMENDING APPROVAL**

**ONE (1) LOT SUPPLY OF LABOR AND MATERIALS FOR THE PROVISION OF VARIOUS SERVICES SUCH AS PHOTOCOPY, BLUE AND WHITE PRINTING, BINDING, DUPLO/RISO PRINTING, COLORED PRINTING, CAD PLOTTING, TARPAULIN PRINTING, NOTEPAD AND CALLING CARD PRINTING AND PRINTING OF SIGNAGES ON ACRYLIC BOARD AND FABRICATION OF TEMPORARY VEHICLE PLATE FOR THE OFFICIAL SERVICE OF PPA PMO ZAMBOANGA FROM OCTOBER 1 TO DECEMBER 31, 2022, WITH AN ABC OF PHP353,700.00**

WHEREAS, the Philippine Ports Authority, PMO Zamboanga, through its Bids and Awards Committee (BAC) and in accordance with the Revised IRR of RA 9184 posted and advertised the Invitation to Bid including the Bidding Documents for the One (1) Lot Supply of Labor and Materials for the Provision of Various Services such as Photocopy, Blue and White Printing, Binding, Duplo/Riso Printing, Colored Printing, CAD Plotting, Tarpaulin Printing, Notepad and Calling Card Printing and Printing of Signages on Acrylic Board and Fabrication of Temporary Vehicle Plate for the Official Service of PPA PMO Zamboanga from October 1 to December 31, 2022, with an ABC of Php353,700.00, on August 18 to 25, 2022 in the PPA Procurement Webpage, Philippine Government Electronic Procurement System (PhilGEPS), PMO Bulletin Boards.

WHEREAS, the BAC sent Request for Quotations (RFQs) to three (3) suppliers, namely 1.) Vistas Designs and Ads, 2.) Copier Solutions Specialist, and 3.) Ceejay's Enterprises. Out of the three (3) only two (2) submitted their price quotation.

WHEREAS, the BAC opened the sealed price quotation of the said suppliers on August 25, 2022, at 2:00PM. The results were as follows:
