



BAC RESOLUTION DECLARING LOWEST CALCULATED AND RESPONSIVE QUOTATION AND RECOMMENDING APPROVAL

ONE (1) LOT SUPPLY OF LABOR AND MATERIALS FOR THE FABRICATION OF SIX (6) UNITS OFFICE TABLES, MADE OF HARD WOOD FOR USE OF TMO-ZAMBOANGA DEL SUR (PORT OF PAGADIAN)

WHEREAS, the Philippine Ports Authority, PMO Zamboanga, through its Bids and Awards Committee (BAC) and in accordance with the Revised IRR of RA 9184 posted and advertised the Invitation to Bid including the Bidding Documents for the One (1) Lot Supply of Labor and Materials for the fabrication of Six (6) Units Office Tables, made of hard wood for use of TMO-Zamboanga del Sur (Port of Pagadian) on August 2 to 9, 2021 in the PPA Procurement Webpage, Philippine Government Electronic Procurement System (PhilGEPS), PMO Bulletin Boards;

WHEREAS, the BAC sent Request for Quotations (RFQ) to three (3) suppliers, namely 1.) Simeona Furniture Shop; 2.) Villanueva Furniture, and 3.) Golden Daughter Enterprises. All three (3) suppliers submitted their price quotation. Peniton Trading Corp. of Caloocan City participated through the PhilGEPS Notice also submitted their quotation.

WHEREAS, the BAC opened the sealed price quotation of the said suppliers on August 9, 2021 at 2:00PM. The results were detailed below:
