



BAC RESOLUTION DECLARING LOWEST CALCULATED AND RESPONSIVE QUOTATION AND RECOMMENDING APPROVAL

ONE (1) LOT SUPPLY, DELIVERY AND INSTALLATION OF ONE (1) UNIT INTERACTIVE WHITE BOARD, PRE-ASSEMBLED E-BOARD SOLUTION WITH TV WALL BRACKET (FITS MOST 60-100"/WEIGHT APPROX. 100KGS) TO BE INSTALLED AT THE HARBOR MASTER OFFICE, PPA PMO ZAMBOANGA

WHEREAS, the Philippine Ports Authority, PMO Zamboanga, through its Bids and Awards Committee (BAC) and in accordance with the Revised IRR of RA 9184 posted and advertised the Invitation to Bid including the Bidding Documents for the One (1) Lot Supply, Delivery and Installation of One (1) Unit Interactive White Board, Pre-assembled e-board solution with TV Wall Bracket (fits most 60-100"/weight approx. 100kgs) to be installed at the Harbor Master Office, PPA PMO Zamboanga on August 17 to 24, 2021 in the PPA Procurement Webpage, Philippine Government Electronic Procurement System (PhilGEPS), PMO Bulletin Boards;

WHEREAS, the BAC sent Request for Quotations (RFQs) to three (3) suppliers, namely 1.) Phone Patch Marketing; 2.) JVS Audio System, and 3.) Avid Sales Corporation. Out of the three (3) suppliers only one (1) submitted their price quotation. Tricom Dynamics Inc. of Davao City and Wattsavers Energy Services Co. of Caloocan City participated through the PhilGEPS Notice also submitted their quotation.



To recommend for approval by the Port Manager of the PPA, PMO-Zamboanga, Zamboanga City the foregoing findings.


