WHEREAS, the Philippine Ports Authority, PMO Zamboanga, through its Bids and Awards Committee (BAC) and in accordance with the Revised IRR of RA 9184 posted and advertised the Invitation to Bid including the Bidding Documents for the One (1) Lot Supply, Delivery and Installation of Twenty (20) Units Office Partition/Cubicle with Ergonomic Chair per partition/cubicle for use of Administrative Division personnel, PPA PMO Zamboanga on August 17 to 24, 2021 in the PPA Procurement Webpage, Philippine Government Electronic Procurement System (PhilGEPS), PMO Bulletin Boards;
