ONE (1) LOT SUPPLY OF LABOR AND MATERIALS FOR THE REPAIR/REPLACEMENT AND INSTALLATION OF DEFECTIVE SPARE PARTS OF PPA PMO ZAMBOANGA OFFICIAL VEHICLE, ISUZU CROSSWIND WITH PLATE NO. SHL 746

WHEREAS, the Philippine Ports Authority, PMO Zamboanga, through its Bids and Awards Committee (BAC) and in accordance with the Revised IRR of RA 9184 posted and advertised the Invitation to Bid including the Bidding Documents for the One (1) Lot Supply of Labor and Materials for the Repair/Replacement and Installation of Defective Spare Parts of PPA PMO Zamboanga Official Vehicle, Isuzu Crosswind with Plate No. SHL 746 on August 17 to 24, 2021 in the PPA Procurement Webpage, Philippine Government Electronic Procurement System (PhilGEPS), PMO Bulletin Boards;
