***BAC Resolution Declaring Single Lowest Calculated and Responsive Quotation  
(LCRQ)***

**BAC RESOLUTION NO. PG-ZAM-2022-09-023**

WHEREAS, the Philippine Ports Authority (PPA), Port Management Office (PMO) -Zamboanga, through its Bids and Awards (BAC) Committee and in accordance with the Revised IRR of RA 9184 posted and advertised the Request for Quotation (RFQ) for the project: **One (1) Lot Supply of Labor, Materials and Equipment for “Emergency Installation of Glass Window Panel Including Tabletop Glass at New Admin. Room Former Conference Room, Admin. Building, Port of Zamboanga, Zamboanga City”** with an **Approved Budget of Contract (ABC)** in the amount of One Hundred Nine Thousand Twenty-One Pesos & 40/100 only (**Php109,021.40**) on September 20, 2022 to September 27, 2022 in the PPA and Philippine Government Electronic Procurement System (PhilGEPS) websites, and PMO-Zamboanga’s Bulletin Board;

WHEREAS, the BAC sent Request for Quotations to three (3) suppliers, namely: 1) **LYN Ventures** on September 24, 2022, 2) **JEA Glass Aluminum** on September 26, 2022 and 3) **LZD Glass & Aluminum** on September 26, 2022;

WHEREAS, in response to PPA Website and PhilGEPS publication the BAC Secretariat received an envelope from **LYN Ventures** on September 28, 2022 at 9:57A.M.;

WHEREAS, during the opening of price quotation on September 28, 2022, the envelope of **LYN Ventures** was opened and checked each item of the eligibility documents against a checklist using a non-discretionary “pass/fail” criterion. The BAC found the eligibility documents as sufficient pursuant to Annex H, Section F of Republic Act 9184 and rated as “PASSED”;

WHEREAS, the Chairperson proceeded to announce the price quoted “**As Read**” of **LYN Ventures** in the prescribed canvass form in the amount of **Php108,909.54** less than the **ABC** of **Php109,021.40**;

WHEREAS, the BAC conducted the Bid Evaluation on September 29, 2022 and found no computational error on the prices quoted in the prescribed canvass form;

WHEREAS, the BAC determined **LYN Ventures** as the Single Lowest Calculated and Responsive Quotation in the amount of **Php108,909.54**;

WHEREAS, the BAC prepared the Abstract of Price Quotation showing **LYN Ventures** as the Single Lowest Calculated and Responsive Quotation;

WHEREAS, after the price quotation has been received, opened, examined, and evaluated, the BAC declared the **PRICE QUOTATION OF LYN VENTURES AS THE SINGLE LOWEST CALCULATED AND RESPONSIVE QUOTATION in the amount of Php108,909.54;**

NOW, THEREFORE, We, the Members of the PMO-Zamboanga Bids and Awards Committee, hereby RESOLVE as it is hereby RESOLVED:

- A. To declare the bid of **LYN Ventures** as the **SINGLE LOWEST CALCULATED AND RESPONSIVE QUOTATION** for the procurement of **One (1) Lot Supply of Labor, Materials and Equipment for "Emergency Installation of Glass Window Panel Including Tabletop Glass at New Admin. Room Former Conference Room, Admin. Building, Port of Zamboanga, Zamboanga City"** with an **Approved Budget of Contract (ABC)** in the amount of One Hundred Nine Thousand Twenty-One Pesos & 40/100 only (**Php109,021.40**).
- B. To recommend for approval by the Port Manager of the PPA, PMO-Zamboanga the foregoing findings.


