**BAC RESOLUTION NO. SVP- 11 - 2018**

WHEREAS, the Philippine Ports Authority, PMO-Zamboanga, through its Bids and Awards Committee (BAC) and in accordance with the Revised IRR of RA 9184 under Section 53.9-Small Value Procurement posted the Request for Quotation of "One (1) Lot – Supply and Delivery of Eight (8) units Cabinet, Steel, Mobile for PPA, PMO-Zamboanga with an Approved Budget for the Contract (ABC) of Php 60,000.00 from August 16-23, 2018, in the PPA Website, PhilGEPS Website, and in the PMO Bulletin Boards;

WHEREAS, the BAC sent Request for Quotations (RFQs) to three (3) suppliers, namely: 1) Z.C. LM Enterprises; 2) ZC Filipinas Furniture; and 3) RC Lim Marketing;

WHEREAS, in response to the postings, only Z.C. LM Enterprises and ZC Filipinas Furniture submitted their bid documents before the deadline;

WHEREAS, the BAC opened the sealed price quotation of the said suppliers on August 24, 2018 at 10:00 AM. The results were detailed below:
