BAC RESOLUTION DECLARING LOWEST CALCULATED AND RESPONSIVE QUOTATION AND RECOMMENDING APPROVAL

BAC RESOLUTION NO. SH- 24 - 2018

WHEREAS, the Philippine Ports Authority, PMO-Zamboanga, through its Bids and Awards Committee (BAC) and in accordance with the Revised IRR of RA 9184 under Section 52.1 (b)-Shopping posted the Request for Quotation of "One (1) Lot – Supply and Delivery of Six (6) Units 10 Steps Extension Ladder Fiber for PPA, PMO-Zamboanga Baseport and TMOs Isabela, Ipil, Malangas, Pagadian, and Margosatubig with an Approved Budget for the Contract (ABC) of Php78,000.00 from August 16-23, 2018, in the PPA Website, PhilGEPS Website, and in the PMO Bulletin Boards;

WHEREAS, the BAC sent Request for Quotations (RFQs) to three (3) suppliers, namely: 1) ZC Filipinas Furniture; 2) Asiatic Trading Corporation; and 3) ZC Paperline and Computer Stationers;

WHEREAS, in response to the postings, only Asiatic Corporation and ZC Paperline and Computer Stationers submitted their bid documents before the deadline;

WHEREAS, the BAC opened the sealed price quotation of the said suppliers on August 24, 2018 at 10:00 AM. The BAC extended the submission of price quotation from July 31, 2018 at 10:00 AM to August 24, 2018 at 10:00 AM since only two (2) qualified suppliers were obtained. The results were detailed below:

- b) To recommend for approval by the Port Manager of PPA, PMO-Zamboanga the foregoing findings.


