BAC RESOLUTION DECLARING LOWEST CALCULATED AND RESPONSIVE QUOTATION AND RECOMMENDING APPROVAL

BAC RESOLUTION NO. SH- 17 - 2018

WHEREAS, the Philippine Ports Authority, PMO-Zamboanga, through its Bids and Awards Committee (BAC) and in accordance with the Revised IRR of RA 9184 under Section 52.1(b)-Shopping posted the Request for Quotation of "One (1) Lot – Supply and Delivery of Ten (10) Units Monitor for PPA, PMO-Zamboanga, Zamboanga City with an Approved Budget for the Contract (ABC) of Php150,000.00 from July 17 to July 31, 2018, in the PPA Website, PhilGEPS Website, and in the PMO Bulletin Boards;

WHEREAS, the BAC sent Request for Quotations (RFQs) to five (5) suppliers, namely: 1) Phone Patch Marketing; 2) Electron Comtronics and Service Center; and 3) PC User's Shop; 4) RC Lim Marketing; and 5) Copier Solutions Specialist.

WHEREAS, in response to the postings, all of the five (5) suppliers mentioned above submitted their price quotation before the deadline;

WHEREAS, the BAC opened the sealed price quotation of the said suppliers on July 31, 2018 at 10:00 AM. There were only four (4) suppliers who qualified, and the results were detailed below:






