



ONE (1) LOT – SUPPLY AND DELIVERY OF VARIOUS PAINTS AND OTHER HARDWARE MATERIALS FOR USE IN THE MAINTENANCE OF PORT FACILITIES AT PORTS OF ZAMBOANGA, ISABELA, IPIL, MALANGAS, PAGADIAN AND MARGOSATUBIG

BAC RESOLUTION DECLARING LOWEST CALCULATED AND RESPONSIVE QUOTATION AND RECOMMENDING APPROVAL

BAC RESOLUTION NO. SVP- 23 - 2018

WHEREAS, the Philippine Ports Authority, PMO-Zamboanga, through its Bids and Awards Committee (BAC) and in accordance with the Revised IRR of RA 9184 under Section 53.9-Small Value Procurement posted the Request for Quotation of "One (1) Lot – Supply and Delivery of Various Paints and Other Hardware Materials for use in the Maintenance of Port Facilities at Ports of Zamboanga, Isabela, Ipil, Malangas, Pagadian, and Margosatubig with an Approved Budget for the Contract (ABC) of Php83,500.00 from August 16 to August 23, 2018, in the PPA Website, PhilGEPS Website, and in the PMO Bulletin Boards.

WHEREAS, the BAC sent Request for Quotations (RFQs) to three (3) suppliers, namely: 1) Asiatic Trading Corporation; 2) Dennis Hardware Enterprises; and 3) RC Lim Marketing;

WHEREAS, in response to the postings, only Asiatic Trading Corporation and Dennis Hardware Enterprises submitted their bid documents before the deadline;

WHEREAS, the BAC opened the sealed price quotation of the said suppliers on August 24, 2018 at 10:00 AM. The results were detailed below:


WHEREAS, upon validation of the documents on August 28, 2018, the result of the validation was RESPONSIVE;



- b) To recommend for approval by the Port Manager of PPA, PMO-Zamboanga the foregoing findings.




