

## BAC RESOLUTION DECLARING LOWEST CALCULATED AND RESPONSIVE QUOTATION AND RECOMMENDING APPROVAL

ONE (1) LOT SUPPLY OF LABOR AND MATERIALS FOR THE INSTALLATION OF FORTY-TWO (42) PANELS COMBI BLINDS, FABRIC MADE WITH CRYSTAL CHAIN OF VARIOUS DIMENSIONS FOR USE OF PPA, PMO ZAMBOANGA WITH AN ABC OF PHP200,000.00

WHEREAS, the Philippine Ports Authority, PMO Zamboanga, through its Bids and Awards Committee (BAC) and in accordance with the Revised IRR of RA 9184 posted and advertised the Invitation to Bid including the Bidding Documents for the One (1) Lot Supply and Materials for Installation of Forty-Two (42) Panels Combi Blinds, Fabric made with Crystal Chain of Various Dimensions for Use of PPA, PMO Zamboanga with an ABC of Php200,000.00 on October 1 to 8, 2021 in the PPA Procurement Webpage, Philippine Government Electronic Procurement System (PhilGEPS), PMO Bulletin Boards;
